Subscription price is \$25.00 per year (\$27.00 for foreign subscribers). Special rates are available for subscription agencies. Subscriptions are renewed automatically upon expiration unless the subscriber sends notice of termination. Domestic claims for non-receipt of issues should be made in writing within 90 days of the month of publication. Claims from foreign subscribers should be made within 180 days. Thereafter, the single issue rate will be charged for replacement.
